Steer Validation All 4-H members who wish to show steers in 2022-2023 show season must have them validated. Steer Validation will be held on June 20 & 21, locations and times TBA. Cost will be \$25.00 per head. Deadline to have steers on feed for county show and all major shows is June 30. *Contact Scott Strawn to schedule your appointment.*

State Fair Heifer Validation:

If you plan on showing heifers at the State Fair, you must also have them validated and on feed by June 30th. Registration papers must be transferred in the exhibitors name by that deadline as well. Please contact Scott to schedule validation. **Tri State fair** heifers are not required to be validated but registration transfer must be done by June 30th as well. Cost \$25.00



State Fair Sheep and Goat Validation: If you plan on showing at the state fair the deadline to validate your sheep and goats for the state fair is June 30. Contact Scott Strawn for an appointment for your validation. Cost \$25.00

State Fair Swine Validations:

If you plan on showing barrows at the State Fair they must be validated by June 30th. Fee for validation is \$25. Contact Scott Strawn to set up an appointment.



Record Book: Record Books will be due Monday, June 28th by 5 pm. Please make sure you have the **correct forms from our office** prior to submitting for judging. Forms are also posted on the district 1 4-H website @ <https://d14-h.tamu.edu/record-keeping-and-record-books>. Contact Scott 806-435-4501 if you have any questions. If you plan on completing a Recordbook please let us know at Extension Office. **District Recordbook judging is set for July 7th** If you would like to be a Judge please notify Scott Strawn.
